

# UPDATE N°22 - CAMPAIGN FOR THE RATIFICATION OF INTERNATIONAL AND REGIONAL PROTOCOLS AIMED AT ABOLITION OF THE DEATH PENALTY

This document presents the recent evolution of the campaign. This update is published twice a year to give information about the campaign development (status of ratifications, actions taken by the World Coalition and its members) and suggest taking action in target countries.

As of 16 October 2017, 85 States are parties to the Protocol, and 2 other States have signed the Protocol but have not ratified it yet.

#### **Latest Ratifications**

- → Madagascar: ratification of the Second Optional Protocol to the ICCPR on 21 September 2017.
- → Gambia: signature of the Second Optional Protocol to the ICCPR on 20 September 2017 after the Adama Barrow, President of The Gambia, delivered a speech at the UNGA in New York, in which he reaffirms the "New Gambia's" commitment to human rights. A communiqué from the President's office later stated that " The Gambia will now work to move from signing to ratification and domestication of the signed treaties, to make them effectively in the country". The Attorney General and Minister of Justice, Baboucarr Tambedou, had declared on 23 March 2017 that he wanted the death penalty abolished in The Gambia.

## Actions taken in 2017

- → March 2017: meeting with the "Friends of the Protocol" during the Human Rights Council
- → 1-12 May: during the 27<sup>th</sup> session of the **UPR**, **Morocco** rejected the recommendations to ratify the OP2-ICCPR.
- → 4 May 2017: **Expert Seminar** on 'The Principle of Non-Discrimination. Equality and the Death Penalty' Palais des Nations, Geneva.
- → 22-24 June 2017: International conference on the death penalty on the occasion of the 15th anniversary of the World Coalition, in Washington DC. The conference included several workshops, namely one on the UN mechanisms, namely the **UPR**.
- → October 2017: In country-mission to **Morocco** to identify to causes of the rejection of the UPR recommendation to ratify when it had accepted to consider it in 2012.
- → **Haiti** accepted the recommendations regarding the ratification of OP2-ICCPR in the addendum.
- → Report sent to the **Human Rights Committee** on the **Draft General Comment on Article 6 of the International Covenant on Civil and Political Rights** in partnership with The Advocates for Human rights and FIACAT.
- → Internal Evaluation of the Ratification campaign, which will be reoriented to adapt to the new context.
