

UPDATE N°18 - CAMPAIGN FOR THE RATIFICATION OF INTERNATIONAL AND REGIONAL PROTOCOLS AIMED AT ABOLITION OF THE DEATH PENALTY

This document presents the recent evolution of the campaign. This update will be published every other month to give information about the campaign development (status of ratifications, actions taken by the World Coalition and its members) and suggest taking action in the target countries.

As of 1st May 2015, 81 States are parties to the Protocol, and 3 other States have signed the Protocol but have not ratified it yet.

New Regional Protocol in Africa

The African Commission on Human and Peoples Rights has adopted a regional protocol for the abolition of the death penalty at its 56th ordinary session in Banjul, The Gambia. It has now to be sent to the African Union for adoption.

25th Anniversary of the American Protocol

On 8 June 2015, we will commemorate the 25th anniversary of the adoption of the Protocol to the American Convention on Human Rights to Abolish the Death Penalty.

Several civil society organizations, including the World Coalition, have requested the Organization of American States to address the issue of the death penalty in its 45th Regular Session of the General Assembly, which will be held in Haiti from June 7 to 9, 2015.

New tool: A Ratification Kit for Parliamentarians

Parliamentarians are essential to the process of abolition in several ways. They are central to law-making in their own countries and in most countries, the ultimate decision on ratification rests with parliament, which must approve ratification. This new tool will help them understand the importance and the process of ratification and it will help civil society engage with them.

Actions taken in March-May 2015

- → During the 113th session of the **Human Rights Committee** recommended that **Cote d'Ivoire** ratify the Second Optional Protocol. The Committee also raised the issue of abolition and ratification for **Benin** and **Suriname** based on the information submitted by the World Coalition
- → During the Hearing before the **Inter-American Commission on Human Rights** on the situation of the death penalty in the **Greater Caribbean**, the Greater Caribbean for Life urged the Commission to call on all Member States of the OAS to ratify the protocols aiming at the abolition of the death penalty
- → FIACAT and the World Coalition participated to the pre-session for the **Universal Periodic**Review of **Liberia** and conducted lobbying activities in Geneva
- → Joint statement made during the 56th Ordinary Session of the African Commission on Human and Peoples' Rights
- → Universal Periodic Review of Liberia and Mongolia during which recommendations to fully abolish the death penalty were made
