**The Death Penalty for Drug Offences: Global Overview 2015 – The Extreme Fringe of Global Drug Policy** is HRI's sixth overview on the status of the death penalty for drug offences worldwide. The report identifies 33 countries and territories that retain the death penalty for drug offences, including 10 in which the sentence is mandatory. It also notes that the governments that execute people for drugs are becoming increasingly isolated at the same time as drug control partners from around the world are withdrawing aid and other forms of assistance to these governments.

# About the World Coalition Against the Death Penalty and the World Day

The World Coalition Against the Death Penalty is an alliance of more than 150 NGOs, bar associations, local authorities and unions. The aim of the World Coalition is to strengthen the international dimension of the fight against the death penalty. Its ultimate objective is to obtain the universal abolition of the death penalty.

The World Coalition Against the Death Penalty created the World Day against the Death Penalty in 2003 to help activists worldwide rally to oppose the death penalty and unite behind the struggle for universal abolition.
