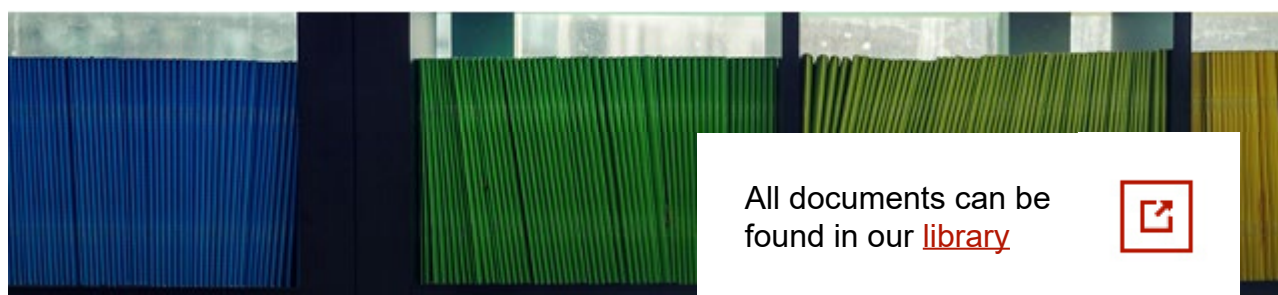
Abolition
