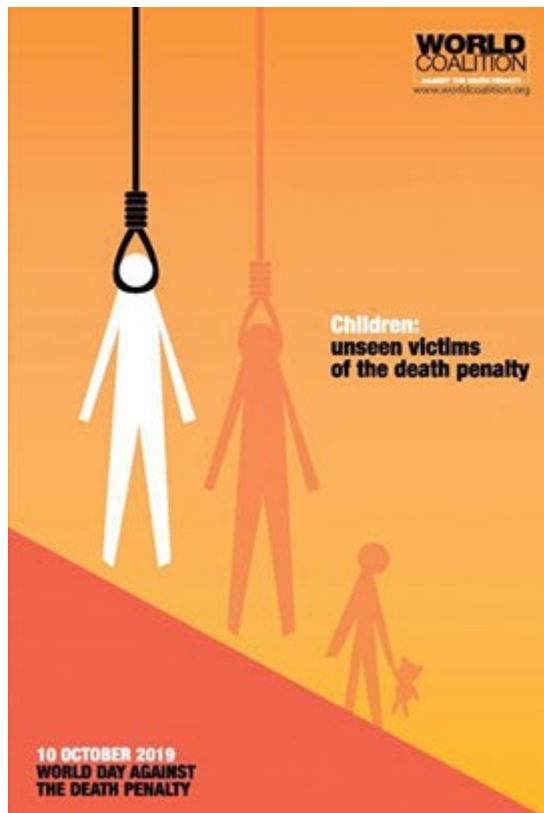

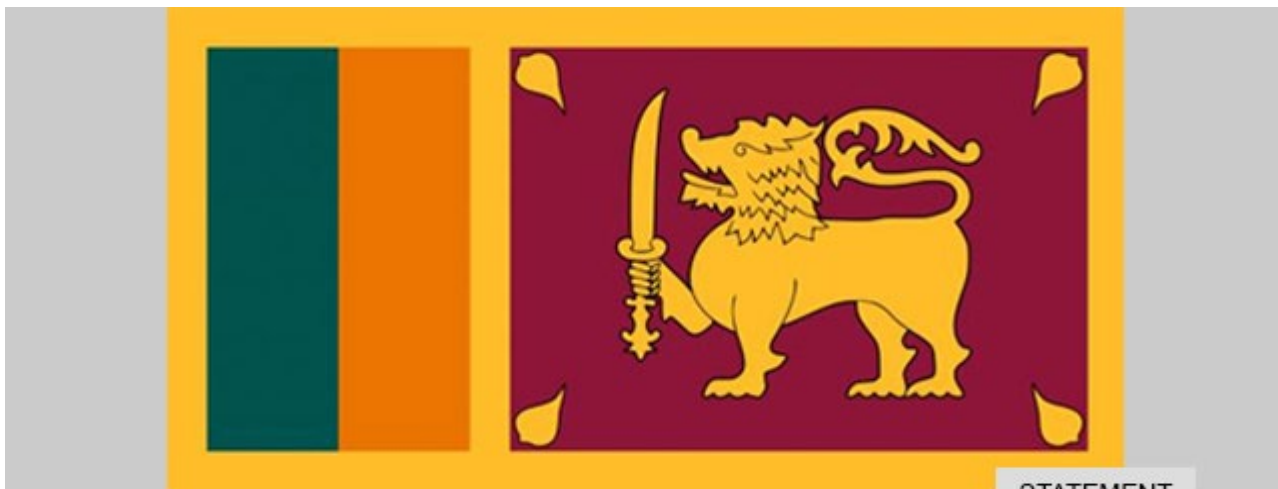


17th World Day Against the Death Penalty: Children, Unseen Victims

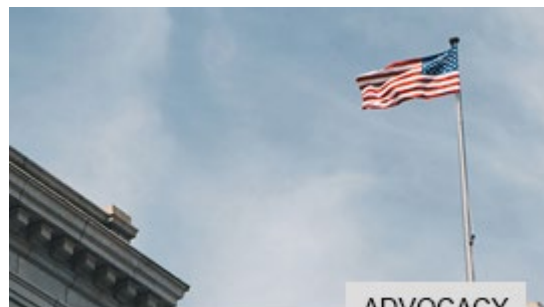

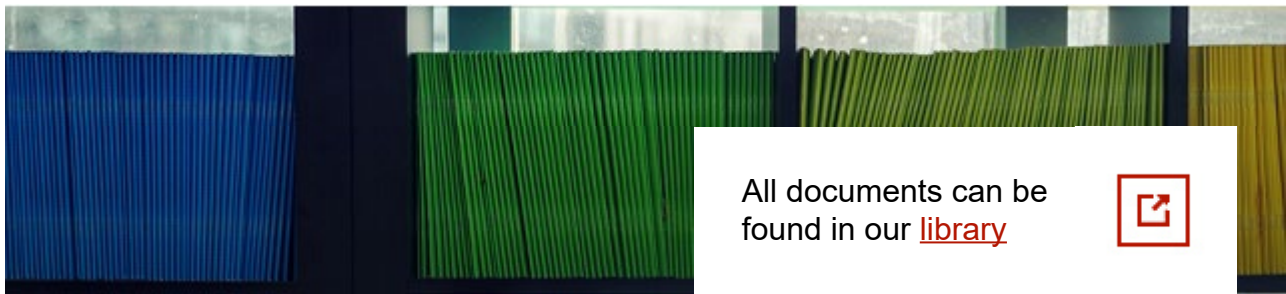
Responsible Business Initiative on the death penalty

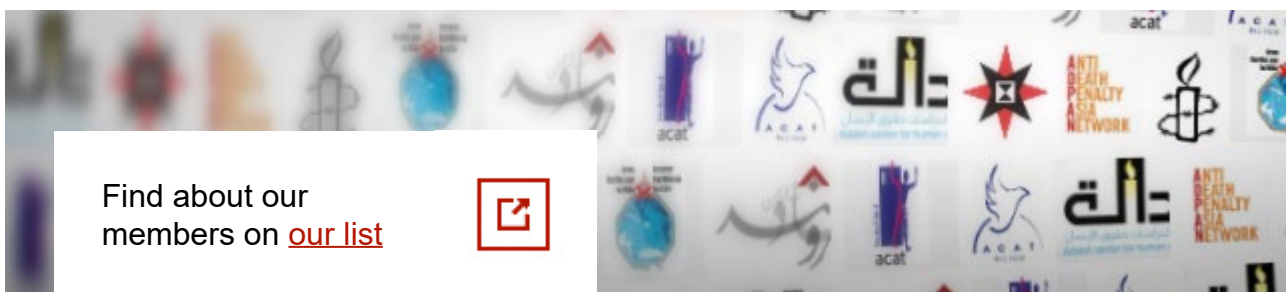
