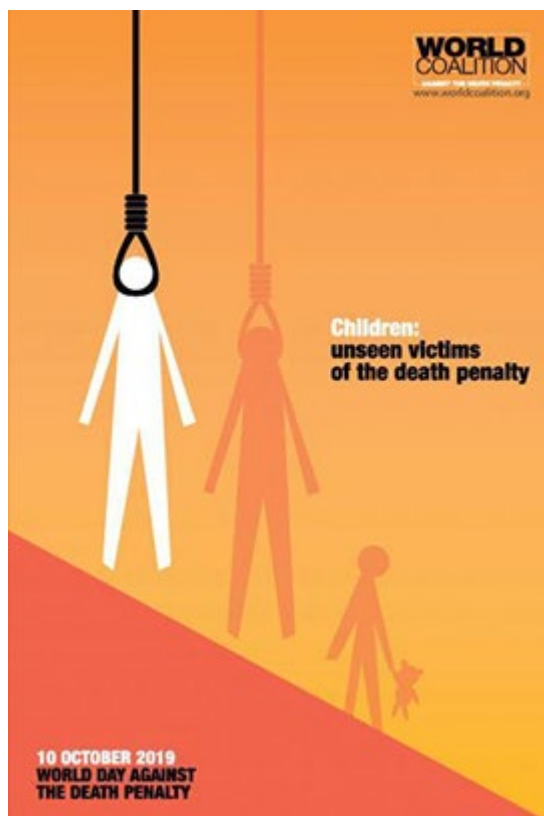

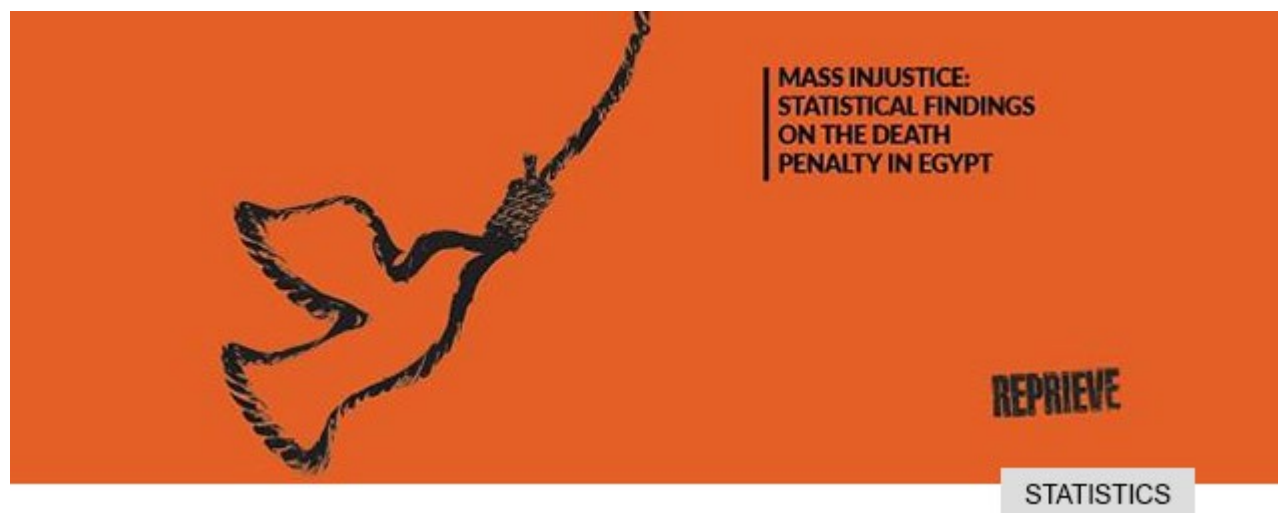

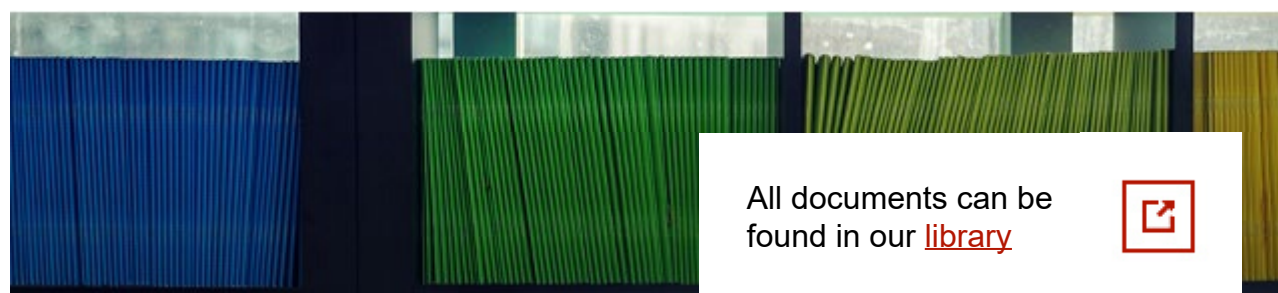
Increased use of the death penalty in Egypt since 2013
